We would kindly ask parents to collect up all the children's personal belongings by the 16th as the area will be cleared out the following week.

After School Club:

We have a variety of exciting activities planned for after school club this term including puppet making, clay modeling, glass painting and a junk modeling competition. If you would like to bring a spare t-shirt in for your child to change into after school please feel free to do so. We do provide painting aprons, however we cannot guarantee uniforms will stay perfectly clean.

There are a variety of after school places still available and anyone wishing to increase sessions should speak to Lyndsey/Alison as soon as possible.

Holiday Club:

Christmas holiday club is expected to be very busy this year.

We will be releasing booking forms shortly. A full day is now £20 and a half day (any 5 hours) is now £10..

Christmas holiday club runs from the 19th of December for one week and then on the 3rd of January.

We would advise that you book your spaces well in advance to avoid disappointment. We are having a Christmas party on the 23rd of December 2-4pm £5 per child, the party can be booked as a separate session!!!

Late Collections of Children:

A polite reminder to parents and carers at after school club. We shut at 6pm and if you are late to collect we have to pay 2 members of staff overtime to look after your child/ren. We will have to charge for late collections in this instance so please make every effort to collect your child on time.

Bill payments reminder:

Bills come out on the 1st of every month, these are the charges for sessions attended the month before. All bills are itemised and state attended sessions, hot lunches and casual bookings.

All bills need to be paid by either cheque (made payable to Dunnington Children), by cash to Lyndsey, or Alison (please ask for a receipt), or by online vouchers. All payments need to be received by the 20th of the same month the bill is issued. All late payments will incur a £5 administrative charge.

Sickness and Injuries:

If your child is unwell or has been injured and they can not attend a pre-booked sessions we would kindly ask that you call to let us know with as much notice as possible. This is so we can monitor patterns of sickness and keep track of any outbreaks such as chicken pox. If you are in any doubt about your child being to attend after a period of sickness please speak to a member of staff before bringing them back. All children suffering from sickness and diarrhea must have a 48hour absence from sessions after their last bout of illness. All pre-booked permanent sessions will still be charged for.
